

What then can Concerned Individuals Do?


- Speak out speak up without fear

The 4 Framework

- Governments as the prime duty-bearer must: respect, protect and fulfill the right to education by making it:
- Available funded, proper infrastructure, safe, adequate educational material, place for recreation, clean, proper training of staff
- Accessibility –All children should have equal access to school inclusion and integration should be upheld

- Acceptability –education should be culturally appropriate for all children. Teaching should be unbiased and objective and material should reflect a wide variety of ideas and beliefs. Corporal punishment should be abolished
- Adaptability programs should be flexible and adjust to changes

- Our commitment to upholding the "Rights" of the child must be rooted in our understanding that "Children learn what they live and live what they learn" My motto is "Touch the heart so you can REACH the head"
- Children must be nurtured, protected, provided for beginning at birth. Everyone is responsible. Everyone benefits as these children will grow up equipped with valuable citizenship skills and competencies

- They will be able to make good choices
- Practice democratic decision making
- Understand the value of sharing responsibilities
- Be able to resolve conflicts effectively
- They will communicate effectively
- And add value to themselves, their families, communities and countries
